# UPDATED COMMENTARY

## ADMINISTRATIVE UPDATE

The Table of Abbreviations has been updated for subscribers' ease of reference to include recent legislative developments and note the repeal of relevant legislation noted in the Index.

Chapters F–O and P–Z have been updated to reflect:

- the renumbering of the *Environmental Planning and Assessment Act 1989*; and
- The repeal and replacement of the below regulations, and inclusion of new regulations in lieu thereof:
  - *Civil Procedure Regulation 2017* (Reg 435 of 2017), which commenced 1 September 2017. The *Civil Procedure Regulation 2012* has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2017.
  - *Commons Management Regulation 2018* (Reg 378 of 2018), which commenced 1 September 2018. The *Commons Management Regulation 2006* has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2018.
  - *Criminal Procedure Regulation 2017* (Reg 437 of 2017), which commenced 1 September 2017. The *Criminal Procedure Regulation 2010* has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2017.
  - *Environmental Planning and Assessment (Savings, Transitional and Other Provisions) Regulation 2017* (Reg 67 of 2017), which commenced 1 March 2018. The *Environmental Planning and Assessment (Savings, Transitional) Regulation 1998* was repealed on 6 January 2012 by Sch 5 of the *Statute Law (Miscellaneous Provisions) Act (No 2) 2011* (62 of 2011).

- *Fire Brigades Regulation 2014* (Reg 551 of 2014), which commenced 22 August 2014. The *Fire Brigades Regulation 2008* (Reg 383 of 2008) was repealed on 22 August 2014 by cl 52(1) of the *Fire Brigades Regulation 2014* (Reg 551 of 2014).
- *Food Regulation 2015* (Reg 622 of 2015), which commenced on 30 October 2015. This regulation repealed and replaced the *Food Regulation 2010* on 30 October 2015.
- *Graffiti Regulation 2014* (Reg 481 of 2014), which commenced on 1 September 2014. The *Graffiti Control Regulation 2009* has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2014.
- *Library Regulation 2018* (Reg 472 of 2018), which commenced on 24 August 2018. This regulation repealed and replaced the *Library Regulation 2010* (Reg 445 of 2010) on 24 August 2018.
- *National Parks and Wildlife Regulation 2019* (Reg 408 of 2019), which commenced on 1 September 2019. The *National Parks and Wildlife Regulation 2009* (Reg 427 of 2009) has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2019.
- *Private Health Facilities Regulation 2017* (Reg 483 of 2017), which commenced 1 September 2017. The *Private Health Facilities Regulation 2010* has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2017.
- *Protection of the Environment Operations (Noise Control) Regulation 2017* (Reg 499 of 2017), which commenced on 1 September 2017. The *Protection of the Environment Operations (Noise Control) Regulation 2008* (Reg 40 of 2008) has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2017.
- *Protection of the Environment Operations (Waste) Regulation 2014* (Reg 666 of 2014), which commenced in part on 1 November 2014, with Pt 5 commencing 1 March 2015 and cll 76 and 79 commencing on 1 July 2015. This regulation repealed and replaced the *Protection of the*

*Environment Operations (Waste) Regulation 2005* (Reg 497 of 2005) from 1 November 2014.

- *Road Rules 2014* (Reg 758 of 2014), which commenced on 1 December 2014. The *Road Rules 2008* (Reg 179 of 2008) were repealed by rule 353-2 of the *Road Rules 2014* (Reg 758 of 2014) from 1 December 2014.
- *Roads Regulation 2018* (Reg 512 of 2018), which commenced on 1 September 2018. The *Roads Regulation 2008* (Reg 156 of 2008) has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2018.
- *Road Transport (Vehicle Registration) Regulation 2017* (Reg 451 of 2017). The *Road Transport (Vehicle Registration) Regulation 2007* (Reg 522 of 2007) has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2017.
- *Strata Schemes Management Regulation 2016* (Reg 501 of 2016), which, except for Pt 8, commenced on 30 November 2016. Part 8 commenced on 1 January 2018. The *Strata Schemes Management Regulation 2010* (Reg 492 of 2010) was repealed by s 275(b) of the *Strata Schemes Management Regulation 2016* (Reg 501 of 2016) on 30 November 2016.
- *Swimming Pools Regulation 2018* (Reg 503 of 2018), which commenced 1 September 2018. The *Swimming Pools Regulation 2008* has been repealed by s 10(2) of the *Subordinate Legislation Act 1989* (Act 146 of 1989), with effect from 1 September 2018.
- *Valuation of Land Regulation 2018* (Reg 282 of 2018), which commence on 22 June 2018. The *Valuation of Land Regulation 2012* (Reg 438 of 2012) was repealed by cl 9(1) of the *Valuation of Land Regulation 2018* (Reg 282 of 2018) on 22 June 2018.

The above changes will be effected in Chapter A–E in the following update to the service.
