Human Rights and Equal Opportunity

Discussion regarding the principle that federal anti-discrimination legislation generally operates concurrently with State regimes of the same nature, meaning an applicant whose circumstances are covered by both State and federal laws could generally pursue remedies under either

[HUM.200] Subject-matter limits

Commentary has been updated with regard to the correspondence between the subject-matter of the application to the Court and the complaint which was made to the AHRC.

Mr Flecknoe-Brown has discussed the possibility that respondents addressing this issue by way of interlocutory application will take upon themselves a more challenging burden to demonstrate that the limitation on jurisdiction is exceeded (especially if the applicant is self-represented: see, eg, Kimber v Owners of Strata Plan No 48216 (2017) 258 FCR 575.

[HUM.250] Relief

New commentary has been added discussing the principle that whether or not economic loss is proved, damages are commonly awarded for non-economic loss as a form of "solatium" for pain and suffering, in a quantum normally up to about \$20,000.

The case of Wotton v State of Queensland (No 5) [2016] FCA 1457 has been analysed regarding orders for a respondent to give an apology. The authorities on the power to make such orders, and the discretionary considerations involved, are discussed.
