### **Filing Instructions**

#### 1. Check the currency of your Service

Ensure Update 175 has been filed.

Before proceeding with the filing instructions, please ensure you have received with this update 2 new tabcards.

#### 2. Insert tabcards

Insert the new tabcard "Joint Criminal Rules" after page 25-1106

Insert the new tabcard "Special Statutory Rules" after page 25-1106.

#### 3. Discard tabcard

Remove and discard the following tabcards and its pages from the service:

#### Magistrates Court Rules

Remove the Magistrates Court Rules tabcard and its pages from 26-1 to 26-1336.

#### • Forms and Practice Directions

Remove the Practice Directions tabcard and its pages from 33-1 to 33-302.

#### 4. File your updating pages

To file this update, you will need to refer to the following table.
