- Where defendant appointed administrator of intestate estate 45 years ago —
Administration of estate not yet finalised — Plaintiff alleging defendant has
maladministered estate and sought account on basis of wilful default; defendant
administrator used beneficiaries' entitlements in estate to provide for their
maintenance and advancement — Court found orders can be made authorising
trustee to apply income of trust for maintenance, education and advancement of
minor beneficiaries.
