TRANSPORT INFRASTRUCTURE (PUBLIC MARINE FACILITIES) REGULATION 2011

The *Transport Infrastructure (Public Marine Facilities) Regulation 2011* commenced on 1 Sep 2011. These extracts include amendments up to the *Local Government (Moreton Bay City Council) and Other Legislation Amendment Regulation 2023* (SL 91 of 2023) which commenced on 28 Jul 2023

TOW TRUCK REGULATION 2009

The *Tow Truck Regulation 2009* commenced on 1 Sep 2009. These extracts include amendments up to the *Transport Operations (Road Use Management—Vehicle Registration) and Other Legislation Amendment Regulation 2023* (SL 83 of 2023) which commenced on 7 Jul 2023.

The *Transport Operations (Road Use Management—Dangerous Goods) Regulation 2018* commenced on 31 Aug 2018. These extracts include amendments up to the *Transport and Other Legislation Amendment Regulation 2023* (SL 24 of 2023) which commenced on 1 April 2023.

TRANSPORT OPERATIONS (MARINE SAFETY) REGULATION 2016 - (EXTRACTS)

The *Transport Operations (Marine Safety) Regulation 2016* commenced on 1 Sep 2016. These extracts include amendments up to the *Transport and Other Legislation Amendment Regulation (No 3) 2022* (SL 122 of 2023) which commenced on 9 Sep 2022.
