UPDATED LEGISLATION

LOCAL GOVERNMENT ACT 1993

The *Local Government Act 1993* commenced on 1 Jul 1993. These extracts include amendments up to the *Community Land Development Act 2021* (Act 6 of 2021) which commenced on 1 Dec 2021.

INTERPRETATION ACT 1987

The *Interpretation Act 1987* commenced on 1 Sep 1987. These extracts include amendments up to the *Statute Law (Miscellaneous Provisions) Act 2023* (Act 7 of 2023) which commenced on 14 July 2023.

LOCAL GOVERNMENT (GENERAL) REGULATION 2021

The *Local Government (General) Regulation 2021* commenced on 1 Sep 2021. These extracts include amendments up to *Local Government (General) Amendment (Tendering) Regulation 2023* (Act 101 of 2023) which commenced on 2 March 2023.

CROWN LAND MANAGEMENT REGULATION 2018 (NSW)

The *Crown Land Management Regulation 2018* commenced on 19 March 2018. These extracts include amendments up to *Crown Land Management Amendment Regulation 2023* (Act 447 of 2023) which commenced on 18 Aug 2023.

LOCAL LAND SERVICES REGULATION 2014

The *Local Land Services Regulation 2014* commenced on 1 January 2014. These extracts include amendments up to *Local Land Services Amendment Regulation 2022* (Act 213 of 2022) which commenced on 13 May 2022.

WATER MANAGEMENT (GENERAL) REGULATION 2018 (NSW)

The *WATER MANAGEMENT (GENERAL) REGULATION 2018* commenced on 24 August 2018. These extracts include amendments up to *Water Management (General) Amendment (Temporary Offence Exemptions) Regulation 2023* (Act 109 of 2023) which commenced on 2 March 2023.

LOCAL GOVERNMENT (MANUFACTURED HOME ESTATES, CARAVAN PARKS, CAMPING GROUNDS AND MOVEABLE DWELLINGS) REGULATION 2021

The *Local Government (Manufactured Home Estates, Caravan Parks, Camping Grounds and Moveable Dwellings) Regulation 2021* commenced on 1 September 2021. These extracts include amendments up to *Planning Legislation Amendment (National Construction Code) Regulation 2023* (Act 71 of 2023) which commenced on 1 May 2023.
