SUCCESSION

- Intestacy — Administration of estates — Where beneficiaries are spouse and intestate’s two children from previous marriage — Entitlement of spouse to appropriate dwelling house — Where value of dwelling house exceeds spouse’s interest in intestate estate — Whether appropriation excludes interest of children — Whether appropriation by spouse imposes an obligation to obtain a valuation of dwelling house — Administration and Probate Act 1929 (ACT), s 49G.
