EQUITY

Trusts and trustees — Constructive trusts — Common intention — A common intention between plaintiff and deceased that plaintiff holds a proprietary interest in the property the subject of the relevant will — Defendant held subject property as constructive trustee for the benefit of the plaintiff — Defendant sold subject property without consulting plaintiff — Defendant transferred proceeds of the subject sale to his personal bank account — Defendant breached duties as constructive trustee.

PRACTICE

Parties — Misjoinder — Third respondent to appeal died after appeal commenced — Neither appellant nor third respondent had paid workers compensation insurance premiums — Nominal Insurer liable to indemnify worker but entitled to recovery from employer — Risk that estate of third respondent might contest Nominal Insurer's entitlement to recover if not jointed to the litigation — Certainty that joinder of third respondent's estate would involve expense and time — Third respondent removed from proceedings.

SUCCESSION

Construction — Whether plaintiff's interest is subject to provisions in the relevant will entitling defendant to the income from investment of the proceeds of sale of subject property in which the plaintiff had an interest prior to the deceased's death.

Executors and administrators — Proceedings against executors and administrators — Application for removal.

SUPERANNUATION

- Application to review decision of Superannuation Complaints Tribunal — Tribunal affirmed trustee's decision to distribute entire death benefit from superannuation fund to deceased member's wife instead of to deceased's estate — Whether Tribunal made decision according to law — Whether no evidence before Tribunal to sustain finding that deceased member had made a Preferred Nomination — Not in dispute before Tribunal that a Preferred Nomination had been made — Whether Tribunal's decision legally unreasonable or irrational or illogical — Trustee given discretion under Trust Deed Rules not to give effect to deceased member's intention — Siblings not financially dependent on deceased member — Wife was a dependant at time of deceased member's death — Whether cultural and customary factors may establish a dependency relationship — Fair and reasonable for Tribunal to accept trustee's decision to distribute entire death benefit to wife — Superannuation (Resolution of Complaints) Act 1993 (Cth), ss 32, 33, 34, 37 — Superannuation Industry (Supervision) Act 1993 (Cth), ss 10, 10A — Superannuation Industry (Supervision) Regulations 1994 (Cth), reg 1.04AAAA.

TRUSTS

- Family trust — Whether trustee had sufficient knowledge of applicants' circumstances to exercise its discretion to distribute income of trust — Whether primary judge erred in finding trustee exercised its discretion upon real and genuine consideration in certain years — Whether decision of trustee void or voidable.

- Removal of trustee — Whether trustee should be removed following breach of trust — Conflict between trustee and two of three remaining beneficiaries — Primary judge erred in finding trustee exercised discretion upon real and genuine consideration — Order for removal of trustee.
