Duty of care - Occupier of premises privately owned jarrah power pole - Where use of power pole exceeded service life and affected by bio-deterioration -Where power pole fell and started bushfire - Whether trial judge erred in finding occupier liable in negligence — Whether occupier owed duty of care to inspect and maintain power pole - Whether occupier breached duty by failing to procure inspection of power pole - Whether the breach caused the Plaintiffs' loss.

Duty of care - Public authorities - Non-delegable duties - Where operator of electricity distribution system placed service apparatus it owned on privately owned consumer power pole - Where network operator engaged independent contractor to undertake work on service apparatus including service cable supported by consumer's pole - Where independent contractor failed to adequately inspect power pole when conducting work - Whether network operator owed a non-delegable duty to ensure independent contractor took reasonable care to inspect the consumer's pole to see that it was in a safe and fit condition for use in the supply of electricity --- Whether network operator took reasonable care in the selection and engagement of independent contractor and auditing of independent contractor's work - Whether trial judge erred in finding duty not non-delegable and effectively delegated — Whether network operator had sufficient control over risk of harm to give rise to non-delegable duty.
