CONTRACTS

Where the defendants contracted to design and build boilers — Where boiler was defective — Where overheating of the boiler's grate caused significant damage to the boiler — Where defect not identified until damage sustained — Whether the reverse operation of the damper was a substantial cause of the overheating that resulted in the damage.

DEEDS

Deed of release — Where deed of release entered in respect of separate matters — Where deed expressly does not apply to claims of which the plaintiffs were not aware of and could not have become aware by making of reasonable enquiries — Where the plaintiffs were not aware that the damper operated in reverse at the time the deed was entered — Whether the plaintiffs could have become aware, by the making of reasonable enquiries, that the damper operated in reverse — Whether defendants released from claims pursuant to the deed of release.

INTERPRETATION

Section 118A of the Mining Act 1978 (WA) — Geological works — Not undertaken upon the land — No written agreement permitting the works — No cash paid — Whether works counted towards minimum expenditure requirements — Whether it was possible for works to count where no written agreement.

JUDICIAL REVIEW

Whether geological works undertaken off the land required written authority — Whether application for forfeiture under s 98 of the Act could have been refused where no written agreement — Whether exercise of mining warden's power miscarried — Whether conduct of sufficient gravity in any event.

LIMITATION OF ACTIONS

Limitation of particular actions — Concurrent duty owed under contract and in tort — Accrual of cause of action and when time begins to run — Whether the first plaintiffs' breach of contract claim was brought within time.
