#### **Transfers**

A new precedent of a Transfer by a Council for Arrears of Rates (Pursuant to a Power of Sale under s 184 of the *Local Government Act 1999*) has been inserted at [6610], with extensive commentary at [6611].

A new precedent of an Application to Register a Transfer of Land (for Arrears of Council Rates) by the Minister for Climate, Environment and Water under s 185 of the *Local Government Act 1999* and s 115A of the *Real Property Act 1886* has been inserted at [6612], with extensive commentary at [6613].

A revised precedent of a Transfer Creating a Life Estate and a Fee Simple in Remainder has been inserted at [3731], with updated commentary at [3732].

#### Caveats

The commentary on a caveat by a statutory chargee claiming pursuant to the *First Home* and *Housing Construction Grants Act 2000* has been updated at [518.30].

#### Fees

#### Tables and Index

The former separate precedents and commentary for an application to note the change of the name of a body corporate, of an incorporated association and of a company which appeared in paragraphs [101]-[102], [109]-[110] and [111]-[112] have been deleted.

### Charges on land

A minor revision has been made at [705] to note the repeal of the Liens on Fruit Act 1923.
