COMMONWEALTH COURTS & TRIBUNALS

FAIR WORK REGULATIONS 2009

The *Fair Work Regulations 2009* commenced on 1 Jan 2010. These extracts include amendments up to the *Fair Work Legislation Amendment (Closing Loopholes) Regulations 2024* (F2024L01031 of 2024) – with effect from 26 August 2024.

FAIR WORK (REGISTERED ORGANISATIONS) REGULATIONS 2009

The *Fair Work (Registered Organisations) Regulations 2009* (formerly titled *Workplace Relations (Registration and Accountability of Organisations) Regulations 2003*) commenced on 23 May 2003. These extracts include amendments up to the *Fair Work Legislation Amendment (Closing Loopholes) Regulations 2024* (F2024L01031 of 2024) which commenced on 21 August 2024.

QUEENSLAND COURTS

JURY REGULATION 2017

The *Jury Regulation 2017* Pt 5 and Sch 2, reproduced below, commenced on 2 Sep 2017. These extracts include amendments up to the *Justice Legislation (Allowances and Other Matters) Amendment Regulation 2024* (SL 62 of 2024) which commenced on 1 July 2024.

UNIFORM CIVIL PROCEDURE RULES 1999

The *Uniform Civil Procedure Rules 1999* commenced on 1 Jul 1999. These extracts include amendments up to the *Uniform Civil Procedure (Fees) and Other Legislation Amendment Regulation (No 2) 2024* (SL 204 of 2024) which commenced on 13 September 2024.
