TAXATION

- Income tax — Whether an unpaid present entitlement to income or capital of a trust estate is a loan for the purpose of s 109D(3) of the Income Tax Assessment Act 1936 (Cth) — Whether the applicant made a loan within the meaning of s 109D(3) of the Income Tax Assessment Act 1936 (Cth) — If a loan is made, whether s 6-25 of the Income Tax Assessment Act 1997 (Cth) prevents the remaining deemed dividends from being included in the applicants' assessable incomes.

WILLS AND ESTATES

- Deceased bequeathed 1 out of 100 parts of estate to adult daughter — Deceased's will stated that daughter's share should be limited given longstanding lack of contact — Adult daughter had limited financial means — Whether provision for adult daughter failed to satisfy deceased's moral duty — Trial judge ordered applicant be paid 10 additional parts — Appeal allowed — Discretion re-exercised so daughter paid 15 additional parts.
Gash v Ruzicka 52
- Deceased executed will in April 1998 appointing Public Trustee as executor — In December 2018 deceased executed a second will appointing his solicitors as executors — In May 2019 Public Trustee appointed guardian of deceased for financial matters and Public Guardian as deceased's guardian for personal matters — Whether deceased had testamentary capacity when will executed in December 2018.
