Prohibition of taking adverse action against person to prevent exercise of workplace right — Workplace right — Airline decided to outsource ground handling operations — Decision to outsource constituted adverse action in respect of affected employees — Affected employees had no presently existing workplace right to organise and engage in protected industrial action and to participate in enterprise bargaining at time of outsourcing decision — Whether prohibition only prohibited adverse action taken to prevent exercise of presently existing workplace right — Fair Work Act 2009 (Cth), ss 340, 341, 361.
