## **CONSTITUTIONAL LAW (CTH)**

Executive power of the Commonwealth — Statutory power conferred on Minister — Power to be exercised only by Minister personally — Ministerial Instructions required departmental officers to refer requests to Minister only where officer satisfied that “unique or exceptional circumstances” exist — Whether Ministerial Instructions purported to instruct departmental officers to make decisions required to be exercised by Minister personally — Whether Ministerial Instructions exceeded limits of executive power as constrained by s 351 of Migration Act 1958 (Cth) — Commonwealth Constitution, ss 61, 64, 67.

## **CRIMINAL LAW (CTH)**

Commonwealth offences — Conspiracy — Conspiracy to import commercial quantity of border controlled drug — Elements of offence — Jury directions — Whether trial judge failed to direct jury properly on element of offence regarding quantity — Scope of conspiratorial agreement — Whether directions wrongly permitted jury to have regard to conduct of co-conspirators outside of accused’s presence — Criminal Code (Cth), ss 11.5, 307.1.
