#### Common law

## Duty of care

In *Elisha v Vision Australia Ltd* [2024] HCA 50, the plaintiff was involved in an incident at a hotel whilst on a work-related trip and was summarily terminated for serious misconduct. See [5.550].

In *Kemp v Gold Coast Hospital and Health Service* [2024] QSC 259, a radiographer/sonographer lodged a complaint about his co-workers to the Office of the Health Ombudsman, and it accidentally disclosed his identity to his employer. See [5.570].
