34 TRANSPORT

1. Replace existing spine patch “34 Transport” with new patch “34 Transport 34.1–34.2”.
2. Slide new patch “34 Transport 34.3–34.4” into the slot on the spine of your new Laws of Australia binder.
3. After p 1284 of 34.2 “Aviation”, move all remaining pages corresponding to 34.3 “Shipping” and 34.4 “Admiralty” (including tab cards) to the new binder “34 Transport 34.3–34.4”. Volume 34 should now be spread across 2 binders.
