LEGISLATIVE AMENDMENTS

Bankruptcy Act 1966

Sections 40, 64A and 64C of the *Bankruptcy Act 1966* (Cth) have been amended by the *Statute Law Revision Act (No 1) 2014* (Cth), No 31, 2014. These amendments commenced on 24 June 2014.

Sections 5, 13, 18AA and 20G of the *Bankruptcy Act* 1966 (Cth) have been amended by the *Public Governance, Performance and Accountability* (*Consequential and Transitional Provisions*) *Act* 2014 (Cth), No 62, 2014. These amendments commenced on 01 July 2014.

Section 82 of the *Bankruptcy Act* 1966 (Cth) has been amended by the *Trade* Support Loans (Consequential Amendments) Act 2014 (Cth), No 82, 2014. This amendment commenced on 18 July 2014.

Cross references have been updated throughout the *Bankruptcy Act 1966* (Cth).

Bankruptcy Regulations 1996

A recent amendment to the *Bankruptcy Regulations* 1996 (Cth) by the *Bankruptcy Amendment (2014 Measures No 1) Regulation 2014* (Cth) which inserted reg 4.10A, a fee for presentation of debtor's petition, has been disallowed. The Senate disallowed Item 4.10A of Schedule 1 of the amending Act on 23 June 2014.

Bankruptcy (Fees and Remuneration) Determination 2014

Item 2.11 of the *Bankruptcy (Fees and Remuneration) Determination 2014* (Cth), for a fee to be charged to present a debtor's petition, has been disallowed. The Senate disallowed Division 2.11 on 23 June 2014.

Federal Circuit Court of Australia Act 1999

Section 20 of the Federal Circuit Court of Australia Act 1999 (Cth) has been amended by the Statute Law Revision Act (No 1) 2014 (Cth), No 31, 2014. This amendment commenced on 24 June 2014.

Section 117 of the Federal Circuit Court of Australia Act 1999 (Cth) has been amended by the Public Governance, Performance and Accountability (Consequential and Transitional Provisions) Act 2014 (Cth), No 62, 2014. These amendments commenced on 01 July 2014.
