Legislative amendments

The Motor Accident Insurance Regulation 2004 (Qld) has been amended as below by the Motor Accident Insurance Amendment Regulation (No 1) 2014, Act 98 of 2014, which commenced on 1 July 2014:

• s 27A – Prescribed limits for particular definitions — Act, s 4: amended.

The *Guardianship and Administration Act 2000* (Qld) has been amended by the *Public Guardian Act 2014*, Act 26 of 2014, which commenced on 1 July 2014:

- ss 12, 13A, 14, 29, 41, 42 and 43: amended; and
- Ch 8 Adult guardian: repealed.

The *Civil Liability Regulation 2003* (Qld) has been amended by *Public Safety Business Agency Act 2014*, Act 17 of 2014, which commenced on 21 May 2014 and amended Schs 1 and 2.
