## **ADMINISTRATIVE LAW**

## **DAMAGES**

Consequential losses flowing from failure to make timely payment of indemnified amount — Whether obligation to indemnify insured arises under insurance contract or Insurance Contracts Act 1984 (Cth), s 54(1) — Whether loss of profits caused by insured’s improvidence too remote in the context of an insurance contract for property damage cover.
